4 CHAIRWOMAN DEELEY: Good morning. I  
5 would like to call to order the meeting of  
6 Wednesday, April 28th, of the offices of the  
7 Commissioner's Board of Election.

8 We will begin with any in person public  
9 comment. Commenters shall state where they  
10 live or if they are not a resident of  
11 Philadelphia that they are a Philadelphia  
12 taxpayer.

13 Public comment is not an opportunity  
14 for dialogue or Q & A. It's a public comment,  
15 a chance to tell us what you think.

16 Each speaker shall have two minutes.  
17 However, I may extend this time at my  
18 discretion. All public comments must be  
19 relevant or germane toward business.

20 Finally it is my responsibility to  
21 preserve order and decorum of the meetings and  
22 as such profane, slanderous, discriminatory or  
23 personal attacks will not be tolerated.

24 Anyone wishing to offer public comment

1 at this time, please step forward.

2 Anyone here for polling place changes,  
3 I would ask that you please hold your comment  
4 until that portion of the meeting. Does  
5 anybody here have public comment, please step  
6 forward.

7 CHAIRWOMAN DEELEY: Please state your  
8 name for the record.

9 MR. GARELLA: My name is Rich Garella.  
10 I'm a resident and taxpayer of Philadelphia  
11 with Protect Our Vote Philly. I wanted to ask  
12 you today about the practice of this Board to  
13 introduce motions that the public has never  
14 been advised on.

15 We believe this deprives the public of  
16 the reasonable opportunity to comment on  
17 official actions that the Sunshine Act  
18 guarantees in section 7.11. Our suggestion is  
19 to do as many other boards -- in which other  
20 boards and agencies do. Which is simply to  
21 publish an agenda approximately 24 hours in  
22 advance telling the public which motions are  
23 likely to be deliberated and voted on in the  
24 upcoming meeting.

1                   Otherwise you have a public comment  
2                   period at the beginning of the meeting, then  
3                   you cut off public comment and then you  
4                   introduce a motion on a topic that the public  
5                   has never heard of. That's not a reasonable  
6                   opportunity. We would be happy to work with  
7                   you to come up with an easy and effective way  
8                   to do this.

9                   The second point I would like to make,  
10                  which is closely related, is that I have here  
11                  a couple of public comments that were  
12                  submitted by email and we would like to urge  
13                  the Board to change its practice of merely  
14                  announcing that emailed comments came in and  
15                  actually then do what other boards and  
16                  agencies do, which is to read out those public  
17                  comments partly summarized, maybe answer  
18                  points that they raised if possible.

19                  Otherwise these comments are not really  
20                  truly public and then they should also be  
21                  appended to the transcripts that are posted so  
22                  that the public can see them. So that they  
23                  just don't kind of disappear into a hole and  
24                  never see them again which is very

1 discouraging for the public.

2 So if you would consider making these  
3 changes hopefully so that it can consistently  
4 happen and it will be true.

5 CHAIRWOMAN DEELEY: That's time. Thank  
6 you. We will now ask Commissioner Sabir for  
7 the report from the Secretary regarding  
8 emailed public comment.

9 COMMISSIONER SABIR: Good morning. All  
10 comments that were emailed by 9:45 were shared  
11 with the Commissioners and the Deputies at the  
12 beginning of the hearing and available at the  
13 public comment table. We received two  
14 comments from Rich Garella and Kevin -- I  
15 don't know how to pronounce it correctly. I  
16 have received them and asked that they be  
17 moved into record.

18 CHAIRWOMAN DEELEY: Commissioner  
19 Schmidt?

20 COMMISSIONER SCHMIDT: I also reviewed  
21 them and agreed that they should be moved.

22 CHAIRWOMAN DEELEY: I have also  
23 reviewed it and ask that it please be moved  
24 into record. Commenters?

1 I just wanted to address two things  
2 that have come up. One is that our public  
3 emailed comments are posted with the  
4 transcripts and also wanted to address  
5 something that came up on social media as well  
6 as the subject of one of our public comments.

7 We have already begun the transition of  
8 our website to a .gov domain. We would like  
9 to thank you for bringing this to our  
10 attention but please know it is something we  
11 are already working on and it should be  
12 completed within a year along with other  
13 website upgrades.

14 We will now move to old business with  
15 the reports from our Executive Director Joe  
16 Lynch.

17 MR. LYNCH: Good morning,  
18 Commissioners.

19 CHAIRWOMAN DEELEY: Good morning, Joe.

20 MR. LYNCH: The Sunshine report -- we  
21 are currently accepting absentee and mail-in  
22 ballot applications online at [votespa.com](https://votespa.com) or  
23 by paper application. Absentee and mail-in  
24 ballot applications must be received by

1 May 11th.

2 The County Board of Elections office,  
3 City Hall, Room 140, is open for walk-in  
4 voting. Our hours are Monday through Friday,  
5 9 a.m. to 5:00 p.m. through Election Day.

6 For those interested, please enter City  
7 Hall through the south gates across from the  
8 Ritz-Carlton Hotel. Voters that need a  
9 replacement ballot can order one at  
10 [ballotform.philadelphiavotes.com](http://ballotform.philadelphiavotes.com) or pick up a  
11 replacement ballot at our City Hall office.

12 As of yesterday, we have approved  
13 73,841 absentee and mail-in applications for  
14 the Primary. Of those, 57,420 are paper  
15 applications and 16,421 were electronic  
16 applications.

17 We have produced and sent 72,850  
18 absentee and mail-in ballots so far.

19 Today is the last day, time to petition  
20 the Court of Common Pleas for a court  
21 appointment to an Election Board vacancy.

22 Our Vote by Mail Unit -- since  
23 April 19th we have received 7,075 ballots back,  
24 that includes mail, drop-boxes and satellite

1 office at room 142 to date. Room 142 has  
2 received 10 Military Overseas ballots.  
3 Pick-up -- we made -- went to the post office  
4 in our area up where the warehouse is and  
5 we're actually picking up ballots everyday,  
6 Monday through Saturday.

7 The Election Board Unit has confirmed  
8 5,587 poll workers to date and since the last  
9 report they have trained 328 people that  
10 attended the classes.

11 Our voter registration unit for the  
12 Election cycle -- we processed 111,847 voter  
13 registrations and out of that 8,496 were  
14 paper.

15 That's all I have.

16 CHAIRWOMAN DEELEY: Thank you, Joe. We  
17 will now proceed to the new business of  
18 polling place changes and our system  
19 administrator Joyce Roll.

20 MS. ROLL: Good morning, Commissioners.

21 CHAIRWOMAN DEELEY: Good morning,  
22 Joyce.

23 MS. ROLL: Relocation proposals for  
24 hearings on April 28th. These have been



1 confirmed by the Board leaders and there's no  
2 -- they're accepted.

3 -- Ward 2, Division 2, Ward 2, Division  
4 3, Saigon Maxim Restaurant, 612 Washington  
5 Avenue has been relocated to Gloria Dei Old  
6 Swedes Church, 916 South Swanson Street.

7 -- Ward 2, Division 4, Saigon Maxim  
8 Restaurant, 612 Washington Avenue --

9 CHAIRWOMAN DEELEY: -- Joyce, I'm going  
10 to ask you to hold up. So I know we have a  
11 pretty good list to get through but, as  
12 required, we're going to have to vote after  
13 each change. So if you can just please start  
14 over with 2, 2.

15 MS. ROLL: Okay, sure. Thank you. 2,  
16 2 and 2, 3 Saigon Maxim Restaurant, 612  
17 Washington Avenue has been relocated to Gloria  
18 Dei Old Swedes Church, 916 South Swanson  
19 Street.

20 CHAIRWOMAN DEELEY: The reason for the  
21 move, Joyce?

22 MS. ROLL: Refusal.
