CHAIRWOMAN DEELEY: On Wednesday
September 9th, meeting of the Philadelphia
Board of Elections. We will first move to see
if there is any public comment? Please
proceed to the microphone and state your name
for the record.

MR. GARELLA: Good morning,
Commissioners. My name's Rich Garella. I'm a
voter and tax payer of the City of
Philadelphia. First I would like to thank you
Commissioner Deeley for posting the substance
of the motions that were passed on
August 27th. That's one of our
recommendations to post motions that the Board
has passed.

The next step would be to publish the
meeting notice with the Sunshine Act applied
so the public could see them. Our other
recommendations are on the handout that I left

1 with the Secretary which you should look at.

2 I have a few questions. The grant
3 agreement for the Center for Technology and
4 Civic Life says a convenient working group to
5 work through challenges dividing
6 implementation and that includes the advocacy
7 groups. I wonder which advocacy groups are
8 included and when and how did the Board chose
9 those advocacy groups? Would it be possible
10 to get an answer?

11 You know on Wednesday at the Philly for
12 Change meeting you answered numerous questions
13 from attendees. Why do you make a rule for
14 open meetings if a Board like this one that
15 Members of the Board can't answer the
16 questions from the public. Is there any
17 special reason that these meetings taken place
18 under the Pennsylvania Sunshine Act are the
19 only place where this Board won't answer
20 questions or discuss anything with the public?
21 Why does this Board never seem to deliver on
22 any official action before voting unanimously
23 for whatever motion is brought? As if
24 everything has been decided in advance. I

1 assume there's a reason. You have to note
2 this behavior is not typical.

3 CHAIRWOMAN DEELEY: Two-minutes Mr.
4 Garella.

5 MR. GARELLA: For the Board of
6 Elections to have an open discussion and
7 address the publics' concerns at their
8 meetings. This is disappointing and more than
9 that it's disrespectful.

10 CHAIRWOMAN DEELEY: Anybody else for
11 public comment? You can proceed to the
12 microphone and state your name.

13 MS. BRICKLIN: My name is Lila
14 Bricklin. I'm a voter in the 59th ward of
15 Philadelphia. I'm new to this and I'm already
16 discouraged based on the first speaker but I
17 did come to ask a couple of questions so I
18 will do so.

19 I want an update on the lawsuit
20 challenging third parties candidates on the
21 ballot. People were very concerned about
22 getting their mail-in ballot when I was told
23 yesterday by Commissioner Al Schmidt's staffer
24 that ballots cannot go out until this is

1 resolved.

2 I also want an update on all the other
3 things that are pending and I want to know how
4 this body is going to respond in a timely
5 fashion given that the election is less than
6 eight weeks away and voters need to know.

7 They want to vote by mail. They don't
8 know about the process. They don't know about
9 early voting. I -- they don't know anything.
10 I'm here because I work on the voter
11 registration in Germantown in my community.

12 I'm trying to keep people up-to-date
13 and I called the Commissioner's office like
14 every other week and I spoke with someone
15 yesterday and they don't know.

16 Because everything is kept in
17 Harrisburg in their reports. It seems like
18 this body can't help me. Where can I go for
19 assistance? So I'm just going to get the
20 deer-in-the-headlights thing. Is that how it
21 works?

22 CHAIRWOMAN DEELEY: Thank you for your
23 comment. Is there anyone else for public
24 comment? Hearing none, we will ask for review

1 from the Secretary for emailed public comment.

2 COMMISSIONER SABIR: Good morning.

3 CHAIRWOMAN DEELEY: Good morning.

4 COMMISSIONER SABIR: The Commission's
5 office has received all public commenters
6 email to our office by 9:45 a.m. today
7 September 9, 2020. These comments were shared
8 with each Commissioner and their Deputies at
9 10:00 a.m. today.

12 meeting and are available for the public to
13 review at the public comment table. We have
14 received three public comments. Two from
15 Sharon Strauss and one from Elisa Waxman. I

6 Thank you. Now we'll proceed to any old
7 business. Hearing none, we'll proceed to
8 new business with a report from Charles
9 Stroman about polling places.

10 MR. Stroman: Request permission to
11 pull the mask down. Good morning,
12 Commissioners. The polling place unit has
13 been working throughout the summer to identify
14 polling places for the upcoming general
15 election. Our goal is for as many new polling
16 places as possible -- as many regular polling
17 places as possible.

18 Over the next several weeks I will
19 propose polling places for the Board for
20 approval. The first task this week are the
21 divisions that are currently remaining at the
22 same polling place as the primary election and
23 therefore don't require any action at this
24 time. A copy of the attached list has been

1 given to each Commissioner, the Stenographer
2 and is available for public commenting.

3 Notices were placed on each polling
4 place listed division that would be remaining
5 at their respected polling place. We'll also
6 post the attached list on the
7 Philadelphiagov.com and begin updating the
8 sources for each division. If any of these
9 divisions need to be moved to another polling
10 place, I will bring the change before the
11 Board of Elections for approval and ask that
12 the attached list be moved into the record.

13 CHAIRWOMAN DEELEY: Thank you. I move
14 that these be added to the record.

15 COMMISSIONER SCHMIDT: I second.

16 COMMISSIONER SABIR: All in favor?

17 Aye.

18 CHAIRWOMAN DEELEY: So moved.

19 COMMISSIONER SCHMIDT: Aye.

1 CHAIRWOMAN DEELEY: Thank you, Charles.

2 So I just have one quick motion.

3 In the primary, we prepaid for return
4 postage of the mail-in and absentee ballots.
5 We were one of the few counties in
6 Pennsylvania to do so and it was very popular
7 among our voters.

8 In fact it was so popular that the
9 state has agreed to reimburse counties for the
10 cost of return postage for the 2020 general
11 election.

12 For all the reasons I stated in the
13 primary, I believe that we should hand prepaid
14 return postage for the general election and
15 now the cost will be covered by the State and
16 not our budget. Therefore I motion that for
17 the 2020 general and special election, the
18 staff shall provide prepaid postage to return
19 absentee and mail-in ballots to the County
20 Board of Elections. Do I have a second.

21 COMMISSIONER SCHMIDT: Second.

22 CHAIRWOMAN DEELEY: All in favor?

23 COMMISSIONER SCHMIDT: Aye.

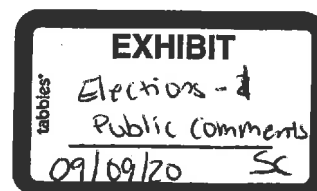

Good morning, Commissioners.



Unfortunately I am not able to attend in person this morning. Please read this letter at the meeting on my behalf.

I am Sharon Strauss. I live in the 9th ward. I am a member of Indivisible NW Philly and Protect our Vote Philly.

The election, coming up in just 54 days, is of critical importance to Philadelphia, all of Pennsylvania, and the entire country. Indeed, the entire world. In this short time, Philadelphians still needs to learn where their polling locations will be—hopefully in time that we can make adjustments in the event that some of the polling places are not

suitable. We also need to make sure we have sufficient pollworkers. The new increase in pay is a fantastic development, but do most Philadelphians know about it? And what is going on with the mail-in ballot drop-off locations? I could not find information about them when I searched your website last night. Granted, there is still plenty of time to get the drop-box information out, but MANY voters—including me—are very concerned about how we will make sure you get our ballots given the sad state of mail service in Philadelphia. And, as I have mentioned many times before, I would love to see better documentation on how you are collecting, securing, and otherwise processing ballots. POVPhilly does NOT want to spend another election day in court, waiting for a judge to make you post this public information.

I am very appreciative of the many difficulties you have running this upcoming election. It is hard to even imagine all the complications with the changes in election law, a deadly pandemic, and new voting equipment happening right now. Not to mention the uncertainty of several ongoing lawsuits that might bring even more complications to you. We all want to see you succeed. We all want a clean election that cannot be viably contested in court.

Now is the time to not just prepare, but to widely share your plans with the public.
