4 CHAIRWOMAN DEELEY: Good morning. I  
5 will now call the meeting on Wednesday  
6 September 23, 2020 Philadelphia Board of  
7 Elections. We will start with public comment.

8 Before I get there, let me just say if  
9 you are here to comment about polling place  
10 location we will hold those locations until  
11 the new business portion of the meeting.

12 So we will move to public comment.  
13 Commenter's shall state where they live or if  
14 they are not a resident of Philadelphia, that  
15 they are a Philadelphia taxpayer. Public  
16 comment is not an opportunity for dialogue or  
17 Q and A. It is public comment. A chance for  
18 you to tell us what you think. Each speaker  
19 shall have two minutes. However I may extend  
20 this time at my discretion. All public  
21 comments must be relevant and remain toward  
22 business.

23 Finally it is my responsibility to  
24 preserve the order and decorum of the meeting.

1 As such profane, slander, discriminatory or  
2 personal attacks will not be tolerated.

3 Anyone wishing to offer public comment,  
4 I will ask that you step forward.

5 But before we do that, I would like to  
6 take a moment of silence to honor Justice Ruth  
7 Bader Ginsburg. Thank you. Thank you very  
8 much.

9 If anyone is here to issue public  
10 comment, please step forward and state your  
11 name for the record. Is anyone here to offer  
12 public comment not related to polling places?  
13 Thank you. We will proceed to a report from  
14 the Secretary, Commissioner Sabir.

15 COMMISSIONER SABIR: Good morning. The  
16 Commissioner's office has received all public  
17 comments that were emailed to your office as  
18 of 9:45 today September 23, 2020. These  
19 comments have been shared with each  
20 Commissioner and the Deputies to review at  
21 10:00 a.m. today.

22 These comments were also provided to  
23 each Commissioner at the beginning of the  
24 meeting and are available for the public to

1 review at the public comment table. We have  
2 received two public comments. One from  
3 Protect Our Vote Philly and the other from  
4 Sharon Strauss. These comments were forwarded  
5 to our office during last week's meeting and  
6 were not addressed. Having reviewed these  
7 comments and asked that they be moved into the  
8 record.

9 CHAIRWOMAN DEELEY: Thank you.

10 COMMISSIONER SCHMIDT: I've also  
11 reviewed these comments.

12 CHAIRWOMAN DEELEY: I had also reviewed  
13 them. Please move into the record.

15 (Whereupon, Elections-1 was marked for  
16 identification.)

17 \* \* \* \* \*

18 We will now proceed with old business from a  
19 report from our executive director Joseph  
20 Lynch.

21 MR. LYNCH: Good morning,  
22 Commissioners. The County Board of Elections  
23 to date we have processed 284,253 absentee and  
24 mail-in applications that were approved.

1                   Absentees -- 27,152 that's 1,487 paper  
2                   and 25,665 online.

3                   Mail-in -- 254,017, 102,392, paper,  
4                   151,625 online.

5                   Civilian overseas -- 779.

6                   The federal voters -- 1,942.

7                   Military -- 363.

8                   Total outstanding ballot applications  
9                   -- there are about 33,000.

10                  Total outstanding ballot applications  
11                  excluding estimated duplicate applications is  
12                  about 13,500.

13                  Our registration notice is the opening  
14                  of registration June 3, 2020. We have  
15                  processed 164,456 new registrations. There  
16                  are 250 outstanding paper applications that  
17                  will be done this morning. There are about  
18                  4,900 electronic applications done overnight  
19                  be the Department of State and they're usually  
20                  (inaudible) by sometime today.

21                  The election ward there is 5,660  
22                  confirmed board workers, 1,476 confirmed  
23                  vacancies and 2,368 confirmed left voice-mails  
24                  and maintenance.

1                   Polling places there's a total of 1,703  
2                   divisions, 1,638 are solved, which is 96.2  
3                   percent.

4                   Facilities use as of now is 685 and we  
5                   have 443 refusals and 22 divisions waiting to  
6                   be heard from.

7                   That's my report for today.

8                   CHAIRWOMAN DEELEY: Thank you, Joe. We  
9                   will now proceed to new business with a report  
10                  of polling places from Charles Stroman.

11                  MR. STROMAN: Good morning,  
12                  Commissioners. Can you hear me?

13                  CHAIRWOMAN DEELEY: Yes, thank you.

14                  MR. STROMAN: As I stated this before,  
15                  many divisions as possible will return to  
16                  their regular polling places meaning that  
17                  where you voted in the 2019 general election.

18                  We would like to move the 568 divisions  
19                  listed on the sheet in front of you from the  
20                  consolidated locations back to the locations  
21                  where they voted in the 2019 general election.  
22                  A copy of the list has been given to each  
23                  Commissioner and is available at the public  
24                  comment table.

1 I ask that the list be moved into the  
2 record or if you would like I could read  
3 through all 568 changes.

4 CHAIRWOMAN DEELEY: Thank you Charlie.  
5 I would just ask if we could hear public  
6 comment and hold off on making that decision  
7 until we hear public comment on the polling  
8 places.

9 If anybody is here to speak on the  
10 polling places, please come forward and state  
11 your name for record.

12 MS. KIM: My name's Kim (Inaudible) and  
13 I am a taxpayer. I live in Northeast  
14 Philadelphia. I'm only here because I have  
15 concern. My father is in a nursing home and I  
16 have not seen him since March 10th due to the  
17 pandemic. When I went there over the weekend  
18 I saw the sign that the polling place was to  
19 be put there and I am very upset with this.

20 We're trying to keep the pandemic at  
21 bay -- I can't see that I cannot visit my  
22 father but yet the public is going to get in  
23 there and vote. Now the administrator told me  
24 that it's going to be in separate -- in the

1 back and they aren't going to have anything to  
2 do with the facility but still yet I'm worried  
3 about that.

4 Can you guarantee the public is not  
5 going to be inside that facility where all the  
6 patients are. I'm scared to death. My father  
7 has not been sick yet but he is declining  
8 because I have not seen him in six months now.

9 I just went to Capitol Hill last week  
10 to speak with my Facebook Group to get the  
11 facilities to open up. We have three Senators  
12 that are helping us. Yet you want to put  
13 polling machines in my dad's facility when the  
14 families cannot visit their loved ones yet the  
15 public is going to go in there and vote.

16 I understand it is essential to vote.  
17 I'm all for voting, yes, but it shouldn't be  
18 in a facility like this. Nursing homes  
19 throughout the United States have said no to  
20 the polling machines, they've taken them out.  
21 Why does this have to be in a nursing home,  
22 please tell me. That's all I'm asking.

23 CHAIRWOMAN DEELEY: Thank you for  
24 coming down. We appreciate it and recognize

1           your frustration. (Inaudible) they said yes  
2           to us, however, we will take your concerns and  
3           with 3, 13 and 14 and we will try to look for  
4           a different location.

5                   MS. KIM: I will greatly appreciate  
6           that.

7                   CHAIRWOMAN DEELEY: We won't know for  
8           today but we know we need to find another  
9           location. Keep in mind those three divisions.

10                  MS. KIM: I understand that and I  
11           greatly appreciate it. Thank you for your  
12           time.

13                  CHAIRWOMAN DEELEY: Thank you for your  
14           time. Sir?

15                  MR. LEWIS: Good morning everyone. My  
16           name is Dequan Lewis (ph). I live in the  
17           Germantown, Lehigh area.

18                   Last election was held at Clymer School  
19           and there's a sign posted right by my house  
20           that the -- it's something about moving back  
21           to I believe it's James Church on Germantown  
22           Avenue and due to the pandemic the church  
23           would be in my opinion really unhealthy  
24           because in the school right we can use the gym

1 to spread out and have more distance between  
2 each other versus going into the church where  
3 when you come into the church you know we have  
4 that table you know register your name and  
5 then you have machine, machine, machine and  
6 it's really really an unhealthy situation due  
7 to the pandemic.

8 We have an abundance of elderly folks  
9 also and my board, myself and volunteers also  
10 has asthma and wants to vote in person because  
11 of the outside issues. So I would just like  
12 to ask that we reconsider that move also.  
13 Thank you.

14 CHAIRWOMAN DEELEY: Sir, can you tell  
15 me your ward and division is.

16 MR. LEWIS: I have it written down I  
17 believe.

18 CHAIRWOMAN DEELEY: It's the 37th ward  
19 but do you know the division?

20 MR. LEWIS: No, I don't.

21 CHAIRWOMAN DEELEY: We will look at it  
22 right now. What's the name of the location  
23 again?

24 MR. LEWIS: It's Clymer Middle School

1           where we last voted and then a sign post today  
2           that's been posted that the hearing moved to I  
3           believe it's James Memorial Church on  
4           Germantown Avenue.

5                   CHAIRWOMAN DEELEY: Is it St. John  
6           Memorial?

7                   MR. LEWIS: St. John.

8                   CHAIRWOMAN DEELEY: I'll see what we  
9           can do. Thank you for being here.

10                  MR. LEWIS: Also real quick. This is  
11           what I haven't been able to find the answer  
12           to.

13                  CHAIRWOMAN DEELEY: Yes.

14                  MR. LEWIS: More polling machines to  
15           help with the distancing and the efficiency of  
16           you know getting people in and out and spread  
17           apart you know.

18                  CHAIRWOMAN DEELEY: We will take your  
19           suggestions under advisement. Thanks for  
20           coming down today. Good morning, sir.

21                  MR. SMITH: Good morning. My name  
22           Randall Smith. I'm from South Philly. I'm  
23           down at 68th and Woodland. Barratt Junior  
24           High School. We've been having to go vote

1 down at Barratt since the 60's and the school  
2 is closed right now and will be closed on  
3 election time. Why has our voting place moved  
4 five blocks out of the area. 68th and  
5 Woodland. Barratt Junior High.

6 CHAIRWOMAN DEELEY: Charlie, can you  
7 comment on that? Barratt? 36th ward 35  
8 division. It's going back to Barrett, sir.  
9 The signs just indicated that you were in  
10 Barrett in June but are going back to Barrett,  
11 you're going back to Barrett in November.

12 MR. SMITH: What about that sign?

13 CHAIRWOMAN DEELEY: That sign is  
14 displayed to let people know where their  
15 polling place is.

16 MR. SMITH: Thank you.

17 CHAIRWOMAN DEELEY: Thanks for coming  
18 down, sir. Good morning, sir.

19 MR. JACKSON: My name is Derek Jackson  
20 (ph). I am the general manager for Park Plaza  
21 Condominiums and I have a letter for the 52nd  
22 ward 10th division from our condo association  
23 president.

24 We had a notice placed on our building

1 and we want to make sure it will go back from  
2 the Carousel House back to 3900 Ford Road. I  
3 have a written statement from our counsel  
4 president.

5 To whom it may concern, it has come to  
6 my attention that the condominium communities  
7 have said they have no interest in serving as  
8 a polling place in the upcoming election.

9 I wish that Park Plaza Condominiums  
10 (inaudible). On behalf of our 350 residents  
11 and commercial staff, it is clear that we are  
12 far more concerned to maintain 3900 Ford Road  
13 as a polling place. We have over 750 persons  
14 residing and working here who consider it to  
15 be a walking convenience to be at (inaudible).

16 Thank you for your consideration.  
17 Sheryl White, President of Park Plaza  
18 Condominiums Association.

19 CHAIRWOMAN DEELEY: Thank you, sir.  
20 Thanks for coming down. Yes, we will be going  
21 back to Park Plaza Condominiums. Is anybody  
22 else here to comment on the polling places?  
23 Come forward, ma'am.

24 MS. WEISS: Hi, my name is Paula Weiss.

1 I'm a community person in 2207 and I'm just  
2 here to say thank you to the City  
3 Commissioner's office and to Charlie Stroman  
4 for putting an investigation into the polling  
5 place that I requested last week. We really  
6 appreciate that and we think it's going to  
7 make a huge difference in our division so just  
8 here to say thank you.

9 CHAIRWOMAN DEELEY: That's very kind.  
10 Thank you so much for coming down.

11 Anyone other comments regarding polling  
12 places? Hearing none, we are going to proceed  
13 back to Mr. Stroman. So I make a motion that  
14 we will vote to approve the list submitted by  
15 Charlie. We are going to hold out 57 ward  
16 divisions 3, 13 and 14 and the 32nd ward,  
17 division 17.

18 COMMISSIONER SCHMIDT: I second.

19 CHAIRWOMAN DEELEY: All in favor?

20 COMMISSIONER SCHMIDT: Aye.

21 COMMISSIONER SABIR: Aye.

22 CHAIRWOMAN DELEEY: Aye. Thank you  
23 Charlie the list has been moved.

24 MR. STROMAN: This list contains wards

1           34 through 66. Notices were placed of the  
2           2020 polling place to propose 2020 general  
3           locations pending in the division.

4                 If the changes are approved, we will  
5           update the running list on  
6           Philadelphiavotes.com and each division. I  
7           will ask that the polling places where the 568  
8           divisions listed on the sheets in front of you  
9           be approved.

10                CHAIRWOMAN DEELEY: Thank you. So  
11           moved.

12                COMMISSIONER SCHMIDT: Second.

14                (Whereupon, Elections-2 was marked for  
15           identification.)

18                CHAIRWOMAN DEELEY: Thank you. So we  
19           will move on to more new business.

20                A key aspect of our strategic and  
21           logistical planning for the November election  
22           is the opening of 15 satellite election  
23           offices in addition to your two existing  
24           locations.

1                   These offices will be crucial to  
2                   provide an alternative option for the votes of  
3                   Philadelphia.

4                   At these satellite offices a voter can  
5                   go to a location and register to vote if  
6                   needed. Request a mail-in ballot in person,  
7                   receive it, vote and return it. All at the  
8                   same location.

9                   In addition voters can bring already  
10                  voted ballots, making the satellite offices  
11                  also drop off locations. Staffing is key to  
12                  everything that (inaudible) especially for  
13                  this year's general election. To both,  
14                  prepare for and educate voters.

15                  By the standards of other departments  
16                  we are not (inaudible). Despite this, we are  
17                  taking on a tremendous burden to meet the  
18                  expectations that the voters have of us.  
19                  Expectations that we understand are paramount  
20                  to democracy and deserve to be met.

21                  When I first made my press release  
22                  regarding the satellite offices last Friday, I  
23                  thought the staffing would be fully available  
24                  to open all 17 locations on Tuesday the 29th

1 of September. The last few days showed that  
2 would not be the case.

3 We have made the assessment that we  
4 will not have enough trained people to open  
5 all 17 offices on September 29th. Rather than  
6 roll the dice and have significant errors and  
7 mistakes, I would like to propose that we do a  
8 rolling opening of satellite offices.

9 We will open seven of the originally  
10 proposed locations on the 29th of September  
11 and then the remaining 10 locations as the  
12 staffing becomes available.

13 This reflects the reality of what we  
14 are able to do right now with current data and  
15 facts. It does not reflect the ideal voting  
16 experience that we would like to achieve.  
17 Furthermore, I will propose that these offices  
18 hold off on issuing replacement ballots to  
19 those voters who have already requested  
20 absentee or mail-in ballots until October 6th  
21 in order to avoid a rush of people whose  
22 ballots are already in the mail from  
23 descending on offices causing lines for those  
24 who have yet to apply.

1 I made the following motion. In  
2 addition to our offices at City Hall and our  
3 office at the corner of Delaware and Spring  
4 Garden Street, the Board of Election has  
5 arranged for additional Philadelphia County  
6 Board of Election offices for the November 3,  
7 2020, special election.

8 These offices will be located at the  
9 following locations.

10 George Washington High School.

11 Joseph H. Brown School.

12 Harding Middle School.

13 J. Hampton Moore School.

14 Liacouras Center.

15 A. B. Day School.

16 Roxborough High School.

17 Mastbaum High School.

18 Creative and Performing Arts School.

1                   Voters of Philadelphia shall be able to  
2                   go to any of these offices as well as the  
3                   offices at City Hall and Delaware and Spring  
4                   Garden for the purpose of requesting absentee  
5                   or mail-in ballots. These offices shall be  
6                   open from 11:30 a.m. to 6:30 p.m. Monday  
7                   through Thursday and 9:30 a.m. to 4:30 p.m.  
8                   Friday, Saturday and Sunday.

9                   Voters shall not be able to request a  
10                  replacement for already requested absentee or  
11                  mail-in ballot at one of those offices until  
12                  starting October 6, 2020.

13                  We will be opening these office as  
14                  quickly as possible beginning on Tuesday  
15                  September 29, 2020.

16                  The following offices shall open on  
17                  Tuesday September 29, 2020.

18                  City Hall.

19                  Gorge Washington High School.

20                  The Liacouras Center.

21                  Roxborough High School.

22                  Tilden Middle School.

23                  Julia De Burgos High School and.

24                  Overbrook Elementary School.

1           The Deputies are authorized to open and  
2           publicize the opening of the remaining offices  
3           as staffing becomes available. Do I have a  
4           second.

5           COMMISSIONER SABIR: Second.

6           CHAIRWOMAN DEELEY: All in favor?

7           COMMISSIONER SABIR: Aye.

8           COMMISSIONER SCHMIDT: Before I vote, I  
9           just want to add something to the record if I  
10          may.

11          CHAIRWOMAN DEELEY: Sure.

12          COMMISSIONER SCHMIDT: I just want to  
13          thank Commissioner Deeley for her tirelessness  
14          and her relentlessness in her leadership as  
15          well as the Deputy Commissioners and our  
16          department staff with all the work that  
17          they've done so far in preparing for the  
18          upcoming election.

19          As indicated for the number of polling  
20          place confirmations, the number of approved  
21          mail-in ballot applications and the number of  
22          poll workers who have been trained.

23          Administering this election is no easy  
24          task. Getting the satellite offices ready to

1 open has been incredibly difficult. I  
2 understand the amount of work we're doing  
3 isn't always visible to the public but rest  
4 assured we're doing the work and using every  
5 resource available to pull off a successful  
6 election.

7 Phasing the opening of the satellite  
8 offices is a managerial decision that will  
9 result in better service for voters.  
10 Philadelphia will have more satellite election  
11 offices than any other county and state and  
12 will be open for longer than any other county.

13 Since Act 77 has passed, we have  
14 repeatedly said that our office is underfunded  
15 and under staffed. The pandemic has only  
16 exacerbated those problems.

17 The grant from CTCL has helped us deal  
18 with some of the pandemic costs but the  
19 structural problems with our budget mainly.

20 As we approach the home stretch for  
21 Election Day it will be imperative upon the  
22 administration to provide the resources and  
23 the staff needed for this election to be  
24 successful.

1                   The number of satellite election  
2                   offices that open up quickly, we can process  
3                   more ballot applications and how quickly we  
4                   can count those ballots after election day is  
5                   directly correlated to the amount of staff  
6                   made available to us by the administration.

7                   This general election will be the most  
8                   challenging election in the history of  
9                   Philadelphia. However I know that we will  
10                  rise to the challenge.

11                  Thank you and I vote in favor.

12                  CHAIRWOMAN DEELEY: Thank you  
13                  Commissioner. All in favor?

14                  COMMISSIONER SABIR: Aye.

15                  COMMISSIONER SABIR: Aye.

16                  CHAIRWOMAN DEELEY: Motion approved.  
17                  Before we adjourn I would just like to make an  
18                  announcement.

19                  Beginning next week for Wednesday's  
20                  Commissioners meeting, we will be moving the  
21                  meeting to be held at the Pennsylvania  
22                  Convention Center. More details of that  
23                  change and that location change will be made  
24                  available on our website as per our

1 requirements by the law to let people know  
2 about the meetings.

3 So this is our last meeting at the  
4 warehouse and I would like to thank the City's  
5 office of audio visual equipment and technical  
6 support that we received. Thank you very much  
7 for their help.

8 Thank you our warehouse staff for the  
9 job that they do to preparing this space for  
10 us to be able to have these meetings and I  
11 especially want to thank the public. You know  
12 this is strange time that we are in indeed and  
13 I have found that the participation in these  
14 meetings in this location have really been  
15 astounding.

16 I'm really happy for the robust  
17 discussion that we heard and just the overall  
18 participation. I hope that we will see the  
19 same level of participation as we transfer to  
20 the Convention Center and I thank everybody  
21 who has participated and my fellow  
22 Commissioners who have been through this bumpy  
23 ride with me so far.

24 We're in the homestretch and we're

1 committed to a successful finish. So thank  
2 you very much and with no more business I


**Philly election meeting in far-flung warehouse criticized for hindering public input**

A watchdog group is shaming the Philadelphia City Commissioners for no longer livestreaming meetings and holding them in an obscure, out-of-the-way location.

The commissioners, who run elections in the city, say they're following state transparency laws, but an expert on those laws says despite that, their recent actions are "disturbing."

The conflict between the group, Protect Our Vote Philly, and the commissioners dates back more than a year. It came to a head after the commissioners' most recent public meeting, at which they announced a major grant from a nonprofit that would help pay for improvements for the 2020 election. They would include pandemic hazard pay for poll workers, setting up neighborhood election offices where voters could drop off mail-in ballots, and offering more secure ballot drop-off boxes.



to make things easier for voters,” he wrote.

POV Philly keeps a frequently-updated document detailing what it sees as the commissioners’ violations of, or “minimal” compliance with, Pennsylvania’s Sunshine Act, which requires government agencies to conduct their deliberations publicly.

It includes more than a year of actions they find troubling, and eight other groups have cosigned it.

Melissa Melewsky, an attorney with the Pennsylvania NewsMedia Association who specializes in public records and transparency issues, said while none of the commissioners’ transparency decisions seem obviously illegal, they’re “far from ideal” and “not sufficient.”

For instance, she said, not releasing meeting minutes seems counterintuitive.

The minutes are public record, and any member of the media or public should be able to file a Right-To-Know request to obtain them. The commonwealth’s Office of Open Records recommends government agencies post their minutes online as a matter of course.

She added, there’s also no reason the commissioners can’t figure out a way to livestream their in-person meetings so people who can’t get to the warehouse in person — a significant barrier, due to its location and the threat of COVID-19 — have a way to see what’s going on.

“This is a point in time where we have agencies clamoring to offer alternative methods of access, and here we have an agency that’s doing less,” she said. “That’s unusual and problematic.”

**Philly election officials said a contract barred them from releasing transcripts. It didn’t.**

After an apparent misunderstanding of their contract with a stenography company, the Philadelphia City Commissioners say they may begin releasing transcripts of their public meetings.

The commissioners, who oversee elections in the city, pay a stenographer to write down what happens at their meetings. But those transcripts don’t become public, nor do the commissioners release meeting minutes.

Asked why, Deputy Commissioner Nick Custodio first said that “per the City’s contract with the stenography company, copies of transcripts must be obtained directly from them.”

Pressed on what exactly the contract required, and why the commissioners couldn’t release abbreviated minutes after their meetings, as many state and city departments do, Custodio changed course.

The transcription contract that covers the commissioners and the city’s other departments, he said, actually “explicitly” allows transcripts to be provided on city websites.

"In her first year, Commissioner [Lisa] Deeley tried to put the transcripts on the website, but the Chairman's office, at the time, gave her that explanation [that the contract forbade republishing]," he said in an email. "It hasn't been revisited since." Deeley began serving as a commissioner in 2016.

For his part, Garella said he's concerned about meeting transcripts because he wants to make sure Philadelphians know how their elections are being conducted — particularly as the city prepares for an unprecedented general election to be conducted during a pandemic, when far more people will vote by mail and the postal service is experiencing significant delays.

"The rules are changing," he said. "This is a time when the Board of Elections really needs to have public input, and when the public really needs to understand and trust what the Board of Elections is doing."
