3	CHAIRMAN SABIR: Good morning.
4	SECRETARY BLUESTEIN: Good morning.
5	CHAIRMAN SABIR: I call to order the meeting of
6	the Philadelphia City Commissioners Board of Elections
7	for Wednesday, October 2nd, 2024. This meeting is in
8	compliance with the Pennsylvania Sunshine Act.
9	Philadelphia City Commissioners are a three-member
10	bipartisan board of elected officials in charge of
11	elections and voter registration for the County of
12	Philadelphia. Each commissioner is elected to serve a
13	four-year term that coincides with the municipal
14	election cycle for mayor and city council.
15	The commissioners set and enforce departmental
16	policies to administer voter registration and conduct
17	elections in accordance with federal and state voter
18	registration and election laws. The city
19	commissioners were created by the Pennsylvania
20	Assembly in 1711 with a focus on taxation and held
21	various regulatory powers throughout the centuries.
22	The commissioners started maintaining voter list in
23	1799 and took on more election related
24	responsibilities, but didn't emerge into its current
25	form until the adoption of Philadelphia Home Rule

1 Charter in 1951.

2 We will start off with public comments. Before beginning their comments, commenters shall state where 3 4 they live or if they are not a resident of Philadelphia and that they are a Philadelphia 5 6 taxpayer. Public comment is not an opportunity for 7 dialoque or Q and A. It is public comment, a chance 8 for you to tell us what you think. Each speaker will 9 have two minutes to speak. However I may extend the 10 time at my discretion. Public comment must concern 11 matters on today's meeting agenda.

12 Finally, it is my responsibility to preserve the order and decorum of meetings. As such, profane, 13 14 slanderous, discriminatory, or personal attacks will 15 not be tolerated. If you wish to make a public 16 objection to a perceived Sunshine Act violation, 17 please raise your hand and I will recognize you. Outbursts will not be tolerated. Anyone wishing to 18 19 offer public comment, please step forward.

Hearing none, we will now move to a report from Secretary Seth Bluestein. Mr. Bluestein, are there any email public comments?

23 SECRETARY BLUESTEIN: There were no e-mail public24 comments as of 9:45 a.m.

25 CHAIRMAN SABIR: Thank you very much. We will

Page 5 1 now proceed to old business. First, we have a report from our Directors of Election Administrations and 2 Operations, Mr. Joseph Lynch and Ms. Stephanie Reed. 3 4 Joe, we'll start with you. Morning Commissioners. 5 MR. LYNCH: 6 CHAIRMAN SABIR: Morning Joe. 7 MR. LYNCH: This is our Sunshine update for 8 October 2nd, 2024. The warehouse unit has been 9 preparing to get the machines ready for the general 10 election and completing the testing of the machines for our voter registration report. The election cycle 11 to date, we have processed 327,190 voter registration 12 13 applications. 175,250 of those applications were 14 As of right now, they have a backlog of 1300 paper. 15 applications. Delaware and Spring Garden is currently 16 working to eliminate the backlog along with making any 17 necessary corrections. As of Tuesday, they have approved 154,811 vote by 18 mail and absentee applications, which is -- which is 19 20 10,574 added from last week's total. Of those, 80,226 are paper applications and 74,585 are electronic 21 22 applications. This includes military, civilian, overseas and federal voters. They currently have a 23

24 total of 2,669 applications waiting to be processed.

25 Of those, 1500 are paper applications and 1,169 are

1 electronic applications.

2 As of October 1st, we have sent out over 153,000 vote by mail ballots for the 2024 general elections. 3 4 Voters, voters who have not yet received their ballots 5 or need a replacement can visit our website to request a replacement ballot or can visit -- can visit one of 6 7 our satellite election offices for assistance. ID 8 verification letters have gone out to voters that either did not include the required proof of 9 10 identification when their absentee/mail in ballot applications or their proof of identification could 11 not be verified by the County Board of Elections 12 13 office.

Voters who have received this letter may submit their proof of ID to the County Board of Elections via email at Phillyelection@phila.gov, fax, US mail, telephone, or in person. Voters have until 5:00 p.m. on November 12th to return their proof of identification for the election.

20 Our satellite office in City Hall, room 140, is 21 now open. Voters can request a mail in or replacement 22 ballot in person and return it all at the same, same 23 visit. Office hours are Monday through Friday, 9:00 24 a.m. to 5:00 p.m., Saturday and Sunday 10:00 to 4:00. 25 Voters who would like to vote by mail for the

Page 7 November 5th election can apply for a mail in or 1 absentee ballot at vote.phila.gov. The deadline to 2 apply is Tuesday, October 29th at 5:00 p.m. 3 4 The Polling Place Unit is working on confirming 5 locations for the November 5th election. Presently, they have confirmed 361 of 367 private locations. 6 7 Public, public locations have been approved, aside 8 from any rebuild projects. They are also going to any 9 new proposed locations that are suggested. Hearings 10 are being set up in advance as confirmation to proposals to come back. We are in constant contact 11 12 with the ward leaders and the community to complete 13 task. Signs for the upcoming hearings are posted as 14 well.

15 The Election Board Unit is working on confirming 16 board workers through calls and emails. They have confirmed 6,836 confirmed so far, but 1,133 have 17 declined and they have left 593 voice mails. 18 Τn 19 general, in the general election training sessions, 20 1,132 board workers attended and 2,308 confirmed for 21 scheduled trainings.

For the satellite office, we continue to serve the citizens of Philadelphia with voter services at satellite election offices, and we want to remind voters that they can visit any site no matter where in

We have a total of seven 2 satellite offices open to the public, seven days a This week we had a grand opening press event 3 week. 4 for District seven satellite election office at 2739 5 North Fifth Street. The event was attended by the media -- by media, election officials and community 6 7 partners.

8 For District 9, 6233 North Broad Street, the 9 grand opening is tomorrow, 10/3 at 9:00 a.m. We have two more satellite offices to open. Additionally, we've been 5 planning for general election communications, including sessions with our consultants and providing 6 7 input for the paid media campaign.

8 Regarding engagement, we're distributing materials at International Bakery, Hong Fang Food 9 10 Market, Fried Chicken Pie restaurant, China Gourmet, Number One Asia Supermarket, and C1 Bakery and Cafe. 11 12 Our efforts also involve sharing flyers for poll workers and interpreters, encouraging voter 13 14 registration, recruiting bilingual interpreters, and 15 engaging with the community through feedback and questions at events. We've also been identifying hair 16 17 salons, temples or churches where we can distribute election materials in the following two weeks. 18

In human resources, we're currently hiring for 30 temps. As of now, our total workforce stands at 211 employees with 177 in civil service and 34 exempts.
This includes 56 clerk Is, 34 clerk IIs, 17 clerk
IIIs, 10 trades helpers, 9 voting machine techs, and 30 temps. We're continuing with new hire activities
and preparing for upcoming orientation.

Page 11 Our IT team has shifted to work for the general 1 election, including police routes for election night 2 and polling place optimization analysis. 3 Thev 4 continue to work on setting up all IT components for 5 our satellite election offices, and they've been updating surveys and sign-up forms, posting notices, 6 7 and maintaining our website.

8 I also just want to note that yesterday I was with our director of safety and security at a tabletop 9 10 exercise that was hosted by the Philadelphia Police. And we got a lot of compliments on the work that we 11 have done so far to bring all the groups together and 12 the planning that we've done, which was really nice. 13 14 And we appreciate the police department hosting that 15 tabletop for us.

16 It's hard to believe that October is already 17 here. Our staff is laser focused on the task they 18 need to complete to be ready for the election. And I 19 want to say thank you to our partners and staff who've 20 been working hard to ensure we're prepared. And 21 that's it.
