3	CHAIRMAN SABIR: Good morning.
4	(Good morning.)
5	CHAIRMAN SABIR: I call to order the meeting of
6	the Philadelphia City Commissioner's Board of
7	Elections for Wednesday, October the 16th, 2024. This
8	meeting is in compliance with the Pennsylvania
9	Sunshine Act.
10	The Philadelphia City Commissioners are a three
11	member bipartisan board of elected officials in charge
12	of elections and voter registration for the city of
13	Philadelphia. Each commissioner is elected to serve a
14	four year term that coincides with the municipal
15	election cycle for mayor and city council. The
16	commissioners set and enforce departmental policies to
17	administer voter registration and conduct elections in
18	accordance with federal and state voter registration
19	and election laws.
20	The city commissioners were created by the
21	Pennsylvania Assembly in 1711 with a focus on taxation
22	and held various regulatory powers throughout the
23	centuries. The commissioner started maintaining voter
24	lists in 1799 and took on more election related
25	responsibility, but didn't emerge into its current

- 1 form until the adoption of Philadelphia's Home Rule
- 2 Charter in 1951.
- We will start off with public comments. Before
- 4 beginning their comments, commenters shall state where
- 5 they live or if they are not a resident of
- 6 Philadelphia and that they are a Philadelphia
- 7 taxpayer. Public comment, it's not an opportunity for
- 8 dialogue or Q and A. It is public comment, a chance
- 9 for you to tell us what you think. Each speaker will
- 10 have two minutes to speak, however, I may extend the
- 11 time at my discretion. Public comment must concern
- 12 matters on today's meeting agenda.
- Finally, it is my responsibility to preserve the
- 14 order and decorum of the meetings. As such, profane,
- 15 slanderous, discriminatory, personal attacks will not
- 16 be tolerated. If you wish to make a public objection
- 17 to a perceived Sunshine violation, please raise your
- 18 hand and I will recognize you. Outbursts will not be
- 19 tolerated. Anyone wishing to offer to public comment,
- 20 please step forward. Hearing none, we will now move
- 21 to a report.
- 22 Secretary Bluestein, are there any public
- 23 comments emailed?
- 24 SECRETARY BLUESTEIN: There, there were no email
- 25 public comments by 9:45 a.m.

- 1 CHAIRMAN SABIR: Thank you very much. We will
- 2 now proceed to old business. We have a report from
- 3 our Directors of Election and Administration, Mr.
- 4 Joseph Lynch and Ms. Stephanie Reed. Joe, we'll start
- 5 off with you.
- 6 DIRECTOR LYNCH: Morning, Commissioners.
- 7 CHAIRMAN SABIR: Morning, Joe.
- 8 DIRECTOR LYNCH: This is our Sunshine report for
- 9 October 16, 2024. The warehouse unit has been working
- 10 to repair machines for the general election. For our
- 11 voter registration report, the election cycle to date,
- 12 they have processed 390,713 voter registration
- 13 applications. 206,500 of those applications were
- 14 paper. As of right now, they have a backlog of 5,300
- 15 applications. Delaware and Spring Garden is working
- 16 to eliminate the backlog and making necessary
- 17 corrections. Just a note, Monday, October 21st, 2024
- 18 is the last day to register to vote. Delaware and
- 19 Spring Garden will be open until midnight to
- 20 accommodate the deadline.
- 21 As of Tuesday, we have approved 182,305 vote by
- 22 mail and absentee applications, which is 12,849 added
- 23 from last week's total. Of those, 93,569 are paper
- 24 applications and 88,736 are electronic applications.
- 25 This includes military, civilian overseas, and federal

- 1 voters. We currently have a total of 2,029
- 2 applications waiting to be processed. Of those, 350
- 3 are paper applications and 1,679 are electronic
- 4 applications.
- As of October 14th, we have sent out 178,467 vote
- 6 by mail ballots for the 2024 general election. Voters
- 7 who have not yet received their ballot or need a
- 8 replacement can visit our website to request a
- 9 replacement ballot or visit one of our satellite
- 10 offices for assistance. ID verification letters have
- 11 gone out to voters that either did not include their
- 12 required proof of identification on their absentee/
- 13 mail-in ballot applications or their proof of
- 14 identification could not be verified by the County
- 15 Board of Elections Office. Voters who have received
- 16 this letter may submit their proof of ID to the County
- 17 Board of Elections via email at
- 18 phillyelection@phila.gov, fax, US mail, telephone, or
- 19 in person. Voters have until 5:00 p.m. on November
- 20 12th to return their proof of identification for the
- 21 general election.
- Our satellite office at City Hall, room 140, is
- 23 now open. The voters can request a mail-in or
- 24 replacement ballot in person and return it all in the
- 25 same visit. Office hours are Monday through Friday,

- 1 9:00 a.m. to 5:00 p.m., and Saturday and Sunday 10:00
- 2 to 4:00. Voters who would like to vote by mail for
- 3 the November 5th general election can apply for a
- 4 mail-in or absentee ballot at vote dot phila dot gov.
- 5 The deadline to apply is Tuesday, October 29th at 5:00
- 6 p.m.
- 7 The Election Board Unit is working to confirming
- 8 board workers through calls and emails. They have
- 9 confirmed 8,003 so far, but 557 had declined, and
- 10 they've left 297 voicemails. In the general election
- 11 training sessions, 2,442 board workers attended and
- 12 2,210 confirmed for schedule and training.
- 13 We are thrilled to share that all 10 satellite
- 14 offices are open to the public. The district 7
- 15 office, located in the Mayfair Shopping Center, opened
- 16 this -- opened yesterday morning. Media, elected
- 17 officials, and community organizations attended the
- 18 grand opening. Voters can visit any site, no matter
- 19 where they live in the city, and we are open to the
- 20 public seven days a week until election day. You can
- 21 find a list of satellite election offices, hours, and
- 22 services on our website at vote dot phila dot gov.
- 23 Thank you, that's all I have.
- 24 CHAIRMAN SABIR: Vice-Chair, do you have any
- 25 questions?

VICE-CHAIR DEELEY: Thank you Mr. Chairman. I

- 2 have no questions, but just for the record, Joe, I
- 3 just -- you misspoke. It was satellite election 6,
- 4 district 6.
- 5 DIRECTOR LYNCH: What did I say?
- 6 VICE-CHAIR DEELEY: You said 7.
- 7 DIRECTOR LYNCH: My Lord.
- 8 VICE-CHAIR DEELEY: Just for the record.
- 9 DIRECTOR LYNCH: Sorry.
- 10 CHAIRMAN SABIR: Strike that.
- 11 VICE-CHAIR DEELEY: Just for the record.
- 12 CHAIRMAN SABIR: Satellite 6.
- 13 DIRECTOR LYNCH: Thank you.
- 14 VICE-CHAIR DEELEY: Thank you.
- 15 DIRECTOR LYNCH: Sorry about that.
- 16 CHAIRMAN SABIR: Secretary Bluestein, do you have
- 17 any questions?
- 18 SECRETARY BLUESTEIN: I have none. Thank you.
- 19 CHAIRMAN SABIR: I'd like to say thank you. I
- 20 know there was a lot of people who were saying that we
- 21 couldn't do this. We got through it. I've been
- 22 working tirelessly and I was actually praying that we
- 23 got these open and we actually got them open. And
- 24 Councilman Driscoll, actually, he had a Bible
- 25 scripture. He said that the last shall be first and

- 1 the first shall be last. And so, you know, it just
- 2 really brought everything back together. We still
- 3 have a lot of work to do. We have to let our
- 4 constituents know what those satellite offices do, and
- 5 we want -- if we want to get the participation up
- 6 there. So that's our next project. Stephanie.
- 7 Sorry.
- 8 DIRECTOR REED: No problem. Good morning.
- 9 I'm pleased to address you today and share updates
- 10 from our administration report for October 16th, 2024.
- 11 This past week, with only three weeks to go, we
- 12 continued our preparations for the general election.
- In our budget and procurement department, the
- 14 team has been focused on the normal processing of
- 15 invoices and purchase orders, addressing any related
- 16 issues as they arise. We're working with procurement
- 17 to get our final orders approved for the general
- 18 election.
- 19 In communications, we've been designing requested
- 20 materials, including social media graphics, updated
- 21 poll worker documents, and signage for the warehouse
- 22 and city hall. Requested updates were also completed
- 23 for language access materials, the department's atlas
- 24 tool, and one pagers for our satellite election
- 25 offices. Additionally, we have been planning for

- 1 general election communications, including sessions
- 2 with our consultants and providing input for the paid
- 3 media campaign.
- 4 Regarding engagement, we're distributing
- 5 materials at Independence Library, Oregon Market, and
- 6 First Oriental Market. Our efforts also involve
- 7 sharing flyers for poll workers and interpreters,
- 8 encouraging voter registration, recruiting bilingual
- 9 interpreters, and engaging with the community through
- 10 feedback and questions at events. We continue
- 11 identifying hair salons, temples, or churches where we
- 12 can distribute a collection of materials.
- I think there might be a mistake at the end of
- 14 this. I need to double check the number of events
- 15 we're scheduled for. I think it's two.
- 16 In human resources, our total workforce stands at
- 17 224 employees, with 189 in civil service and 35
- 18 exempt. This includes 56 clerk ones, 33 clerk twos,
- 19 17 clerk threes, nine trades helpers, nine voting
- 20 machines techs, and 44 temps. We're continuing with
- 21 new hire activities and preparing for upcoming
- 22 orientations.
- Our IT team completed setting up all IT
- 24 components for our last two satellite election
- 25 offices. They've been updating surveys and signing --

- 1 sign up forms, posting notices, and maintaining our
- 2 website. They've also been working on the call
- 3 center, asset retrieval center, and poll worker
- 4 dashboard. The team has finished new phone setup with
- 5 the help of surge staffing from the city. And one
- 6 note here is that the Shepherd Rec Dropbox is still
- 7 down, and that is, I think, IT related. It's, it's
- 8 not anything that's our fault, but the entire power is
- 9 out at Shepherd Rec.
- 10 DIRECTOR LYNCH: It's up.
- 11 DIRECTOR REED: It's up now?
- 12 DIRECTOR LYNCH: Yeah.
- 13 DIRECTOR REED: Okay, well, never mind. Update.
- 14 It's up. So that's good.
- 15 DIRECTOR LYNCH: I'm sorry. We, we, we found
- 16 out that it went up last night, so we, we had somebody
- 17 go out and open it up.
- 18 DIRECTOR REED: Great. All right.
- 19 CHAIRMAN SABIR: Okay. And were you finished?
- 20 I'm sorry.
- 21 DIRECTOR REED: Just one more thing. With three
- 22 weeks until the general election, our staff's done a
- 23 wonderful job preparing and solving challenges as they
- 24 arise. I'd like to thank them for their ongoing
- 25 commitment and hard work. And I'd also like to thank

- 1 OIT for their support as we've worked together to
- 2 troubleshoot and they provided specialized support
- 3 staffing to help our IT unit. I am finished.
- 4 CHAIRMAN SABIR: Okay. Thank you. Vice-Chair
- 5 Deeley, did you have any questions?
- 6 VICE-CHAIR DEELEY: Thank you. I have none.
- 7 CHAIRMAN SABIR: Secretary?
- 8 SECRETARY BLUESTEIN: Thank you. I have none.
- 9 CHAIRMAN SABIR: I just want to go back, I guess,
- 10 with the, the drop boxes. Now, is the communications
- 11 together between them and a website far as, like,
- 12 what's up or not up? Because I know it's, like,
- 13 another page to the website.
- 14 DIRECTOR REED: Yeah, you know what that was -- I
- 15 just -- that was a news item. And this is something
- 16 Joe and I have talked about. It's really frustrating
- 17 when we put -- I'm sorry. It's frustrating when we
- 18 put the, like, details in a news item. What we need
- 19 to do moving forward is link back to the main page.
- 20 Because what happens then is, when people search, they
- 21 can find an old news item, and it was one that was
- 22 missed. He did update it, but he and I talked about
- 23 as soon as we get through this election, really
- 24 thinking about, like, where we put things, how they
- 25 link back so that we don't have multiple places where

- 2 CHAIRMAN SABIR: So there's no possible way we
- 3 could change that for this election? It's no possible
- 4 way?
- 5 DIRECTOR REED: Well, we did update that one. It
- 6 is updated.
- 7 CHAIRMAN SABIR: Okay. That's what I'm saying.
- 8 Just make sure that we do the updates --
- 9 DIRECTOR REED: We did.
- 10 CHAIRMAN SABIR: -- on that backside. That's
- 11 all.
- 12 DIRECTOR REED: Yep, we did. For sure.
- 13 CHAIRMAN SABIR: Sure. Okay. Thank you. Thank
- 14 you, I appreciate y'all both.
- 15 DIRECTOR REED: Of course.
- 16 CHAIRMAN SABIR: We will now proceed to new
- 17 business. We will begin considering our first agenda
- 18 item. Vice-Chair Deeley's motion. Vice-Chair Deeley,
- 19 did you want to make a statement before you put your
- 20 motion in or you just wanted to put your motion in?
- 21 VICE-CHAIR DEELEY: Yes, Mr. Chair, a few brief
- 22 comments before I put my motion up.
- 23 CHAIRMAN SABIR: Sure.
- 24 VICE-CHAIR DEELEY: Thank you.
- 25 CHAIRMAN SABIR: Yeah

- 1 VICE-CHAIR DEELEY: So just a quick history
- 2 lesson. When the pandemic hit in 2020 and the number
- 3 of mail ballots requests skyrocketed, the Department
- 4 of State recommended that we purchase these envelope
- 5 grinders to open all the mail. We brought two of
- 6 them, but when it came time to use them, they really
- 7 weren't that effective. First, they only cut one of
- 8 the four sides, so it's not quick to get the contents
- 9 out. But worse, they damaged several thousand
- 10 ballots. Let me repeat, the grinders damaged several
- 11 thousand ballots in the 2020 primary election. These
- 12 ballots needed to be hand recreated one at a time with
- 13 full transparency for the observers. It took a good
- 14 amount of time.
- 15 Afterwards, finding a solution to the envelope
- 16 opening problem was one of our top priorities. We
- 17 traveled the country during the pandemic. We also
- 18 called jurisdictions that vote almost exclusively by
- 19 mail. What we found out is that they all use the
- 20 extraction desks. All of them. Nobody mentioned
- 21 grinders, so we bought extraction desks. They are not
- 22 outdated equipment.
- Now, things with them haven't been perfect. I
- 24 think it was the second election where we had to get
- 25 the service techs out here because they were damaging

- 1 the ballots. But we got them on the right maintenance
- 2 schedule, and since then, they have worked great. Now
- 3 they move at the speed of the operator. Faster
- 4 operators will extract more ballots than slower ones.
- 5 And I know that in the past we have sometimes used the
- 6 grinders on a small scale to help out.
- Now, I know there has been talk about juicing
- 8 this year's process by purchasing additional grinders
- 9 and using them on the secrecy envelopes. And I know
- 10 that Allegheny County uses grinders. But in my
- 11 opinion, we are not in a race against Allegheny
- 12 County. This is a serious election, not a race. It
- 13 would be just immature to try and race another county.
- 14 They have their way of doing things for their unique
- 15 circumstances and we have ours for our unique
- 16 circumstances.
- We have already made a lot of changes leading up
- 18 to this year that will make the count take much less
- 19 time than it did in 2020, namely implementing
- 20 electronic poll books, which means it's not going to
- 21 be days anymore. We do not need to take unnecessary
- 22 risks. We will get people clarity in a reasonable
- 23 time frame.
- I know that I have said no changes in the
- 25 presidential election, and I know that the Chairman

- 1 has delivered that message to everyone numerous times.
- 2 No changes. So I am perplexed as to why we would
- 3 think about changing something about the canvas.
- 4 Maybe everything goes well. Maybe these newly
- 5 purchased grinders that have never been used before or
- 6 tested at scale will work great. Maybe they do not
- 7 damage any ballots. Maybe they speed things up a
- 8 little bit, in which case everyone just forgets that I
- 9 made this motion.
- 10 But this is not the election for maybe because
- 11 maybe the grinders again damage a couple thousand
- 12 ballots, like in 2020 in the primary. Maybe the
- 13 presidential race comes down to a couple thousand
- 14 votes. If that's the case, those will be the most
- 15 watched and anticipated ballot recreations in the
- 16 history of the world. That is, after the lawsuits
- 17 over them have finished. I do not want to risk that.
- 18 If we have new ideas on how to do things more
- 19 efficiently, then let's try it out next year in the
- 20 Controller DA Race, when the people of Denmark don't
- 21 care about the outcome.
- 22 So for the sake of peace of mind, I motion that
- 23 the staff only utilize the extraction desks on -- or
- 24 hand letter openers for the opening of declaration and
- 25 secrecy envelopes, and do not utilize grinders unless

- 1 there is a significant mechanical issue that arises
- 2 with the extraction desks. Thank you.
- 3 CHAIRMAN SABIR: Thank you. Secretary, did you
- 4 want to make a comment?
- 5 SECRETARY BLUESTEIN: Yes, Mr. Chairman. May I
- 6 be recognized, please?
- 7 CHAIRMAN SABIR: Yes, you may.
- 8 SECRETARY BLUESTEIN: First, I just want to thank
- 9 the deputy commissioners and the staff for being
- 10 innovative in trying to find ways to speed up our
- 11 processing times when it comes to the canvas. And
- 12 this is not about being in a race with another county.
- 13 It is about knowing that the world is looking to find
- 14 out when the results will be known.
- 15 In Pennsylvania and in Philadelphia in
- 16 particular, we know that the window of time from when
- 17 the polls close to when the race is called is when is
- 18 at the greatest risk for miss and disinformation and
- 19 harassment and threats to our workers.
- The technology under consideration today was a
- 21 godsend for our department when in the 2020 primary,
- 22 we needed to open 175,000 mail ballots, and we needed
- 23 to use them and get it done quickly. Also, when the
- 24 extraction desks did damage ballots, over 4000 of
- 25 them, in the 2021 primary, we rushed the grinders up

- 1 here to use them to finish the job.
- Now, the grinders that were just purchased have
- 3 already been tested. We have some of the test
- 4 material here, and you can see that they did not
- 5 damage any of the ballots. And the reason for that is
- 6 it's not about which extraction desk or grinder that
- 7 we use. It is about how long the ballot is and how it
- 8 is folded, and when it sits in the envelope properly,
- 9 as these ones clearly do, because it's a smaller
- 10 ballot, there is very little risk for them being cut
- 11 when they're being opened. And the risk doesn't
- 12 change whether it's the extraction desks or the
- 13 grinders. That risk is the same.
- So, you know, I would be remiss in not using a
- 15 technology that can open potentially 40,000 envelopes
- 16 an hour, as opposed to the extraction desks, which can
- 17 only open 3,600 envelopes an hour. So for that
- 18 reason, I do think we should utilize both the
- 19 extraction desks on the outer envelopes and then use
- 20 the secrecy -- the grinders on the secrecy envelopes
- 21 as the professional staff have recommended. Thank
- 22 you.
- 23 CHAIRMAN SABIR: Real quick. Joe, could I call
- 24 you back up, Joe?
- 25 DIRECTOR LYNCH: Sure.

- 1 CHAIRMAN SABIR: So Joe, so you done tests on
- 2 these grinders.
- 3 DIRECTOR LYNCH: Uh-huh.
- 4 CHAIRMAN SABIR: Tell us a little about it. Did
- 5 you just order them or did you talk to, like,
- 6 Allegheny County? Did you talk to other election --
- 7 DIRECTOR LYNCH: No, I didn't talk to any other
- 8 county. I don't need to talk to any other county. I
- 9 just thought that it would be better to have them,
- 10 because there's kind of, like, a choke point --
- 11 CHAIRMAN SABIR: Okay.
- 12 DIRECTOR LYNCH: -- when it comes to take --
- 13 opening up the declaration envelopes at the -- at the
- 14 tables. So I figured if we put one at each -- at the
- 15 end of each station, we would be able to make -- we'd
- 16 be able to open these quicker, the declaration
- 17 envelopes.
- 18 CHAIRMAN SABIR: How long did you --
- 19 DIRECTOR LYNCH: And I ran -- I ran tests
- 20 yesterday and it came out fine.
- 21 CHAIRMAN SABIR: And so just for the record's
- 22 sake, so how long you been running elections, or in
- 23 the election --
- 24 DIRECTOR LYNCH: I've been here 28 years.
- 25 CHAIRMAN SABIR: So in 28 years, you think that

- 1 this is a good idea for us to open it up in this
- 2 election?
- 3 DIRECTOR LYNCH: Yes, I do. I do.
- 4 CHAIRMAN SABIR: Thank you.
- 5 DIRECTOR LYNCH: Those machines are, are awesome.
- 6 They really are.
- 7 CHAIRMAN SABIR: Thank you, Joe.
- 8 DIRECTOR LYNCH: But I, I, I understand what
- 9 the Commissioner is saying. But, I mean, I wouldn't
- 10 jeopardize the election if I didn't think this would
- 11 work, so.
- 12 CHAIRMAN SABIR: You wanted to add something,
- 13 Stephanie?
- 14 VICE-CHAIR DEELEY: Mr. Chairman, if I may?
- 15 CHAIRMAN SABIR: Sure.
- 16 VICE-CHAIR DEELEY: I'm questioning the 40,000
- 17 number since the ballots are batched up, and we're
- 18 not, not going to be running 40,000 at one time, so.
- 19 SECRETARY BLUESTEIN: The, the numbers are
- 20 directly from OPEX's website for how fast the
- 21 equipment can be used. It's no different than saying
- 22 that the -- in theory, the extraction desks can handle
- 23 up to 3,600 per an hour, but as you said in your
- 24 statement, it depends on the user, and in fact, it
- 25 never opens 3,600 per an hour. And in our experience

- 1 over the last four years, each extraction desks
- 2 probably maxes out about 900 per an hour, in real
- 3 world use. So yes, in the real world, it won't hit
- 4 40,000 per an hour, the same way the extraction desks
- 5 don't hit 3600 per an hour.
- 6 CHAIRMAN SABIR: Okay. I mean, it's my
- 7 statement, I guess, is that I don't want this board to
- 8 risk accuracy over speed, you know. However, the
- 9 longer we keep the canvas going, that's a threat to
- 10 our life. You know, in 2020, that little short
- 11 window, you know, it put -- it put all our election
- 12 board workers, in my opinion, life at stake, keeping
- 13 it going longer. And if we have an opportunity, and
- 14 we do have a recommendation from someone who has done
- 15 elections for 28 years and they feel, you know, that
- 16 this is confident that this is going to work. Other
- 17 counties use the same machine, same equipment, and
- 18 they do it faster, you know, but I just wanted to say,
- 19 everybody, to understand your position,
- 20 Vice-Chair Deeley. And I know it's in the best
- 21 interest of the board, and I do. But did you -- so I
- 22 know you made the statement -- I know we just all made
- 23 statements, but for the record, I don't know if I
- 24 clearly heard your actual motion.
- VICE-CHAIR DEELEY: Thank you, Chairman.

1 CHAIRMAN SABIR: Okay.

- 2 VICE-CHAIR DEELEY: So for the sake of peace of
- 3 mind, I motion that the staff only utilize the
- 4 extraction desks or hand letter openers for the
- 5 opening of declaration and secrecy envelopes and do
- 6 not utilize grinders unless there is a significant
- 7 mechanical issue that arises with the extraction
- 8 desks.
- 9 CHAIRMAN SABIR: Is there a second? Hearing no
- 10 second, this motion does not pass.
- We will now move to the next agenda item, polling
- 12 place changes. We will hear from polling place
- 13 investigation supervisor Charlie Stroman.
