2 morning. I call the Return Board for the
3 2022 General and Special Election to order.
4 We have reconvened.

5 First, I will preserve the order
6 and decorum of these meetings. Everyone in
7 attendance should be on notice that shouting
8 out or interrupting the proceedings will not
9 be tolerated. Those who violate this will
10 be asked to leave. The Sunshine Act permits
11 anyone attending a public meeting to object
12 to a perceived violation at any time during
13 the meeting. If you choose to do so, please
14 succinctly state your objection. Objecting
15 is not an opportunity for speechmaking.

16 We will now move to public comment.
17 Commenters shall state where they live or if
18 they are not a resident of Philadelphia that
19 they are a Philadelphia taxpayer, or since
20 this is the Return Board, which candidate
21 they represent.

22 Public comment is not an
23 opportunity for dialogue or Q&A. It's
24 public comment, a chance for you to tell us

1 what you think. Each speaker shall have two
2 minutes. However, I may extend this time at
3 my discretion. All public comments must be
4 relevant or germane to board business.

5 Finally, it's my responsibility to
6 preserve the order and decorum of these
7 meetings. As such, profane, slanderous,
8 discriminatory, or personal attacks will not
9 be tolerated. Anyone wishing to offer
10 public comment, please step forward.

13 now move to Commissioner Bluestein for

15 COMMISSIONER BLUESTEIN:
