4	the meeting of the Philadelphia Board of Elections for
5	Wednesday, December 17th, 2025. I would like to note
6	for the record that Chairman Sabir is present and
7	attending this meeting telephonically.
8	For public comments, we'll start off public
9	comments. Before beginning their comments, commenters
10	shall state where they live, or if they are not a
11	resident of Philadelphia, that they are a Philadelphia
12	taxpayer. Public comment is not an opportunity for
13	dialog or Q&A. It is public comment, a chance for you
14	to tell us what you think.
15	Each speaker will have two minutes to speak.
16	However, I may extend the time at my discretion.
17	Public comment must concern matters on today's meeting
18	agenda. Finally, it is my responsibility to preserve
19	the order and decorum of the meetings. As such,
20	profane, slanderous, discriminatory, or personal
21	attacks will not be tolerated.
22	If you wish to make a public objection to a
23	perceived Sunshine Act violation, please raise your
24	hand, and I will recognize you. Outbursts will not be
25	tolerated. Anyone wishing to offer public comment,

- 1 please step forward.
- 2 As of 9:45 a.m., there were also no email public
- 3 comments. Seeing no public comments, we'll move
- 4 forward with old business with reports from our
- 5 directors of election operations and election
- 6 administration. We'll start with Mr. Joseph Lynch.
- 7 Joe?
- 8 MR. LYNCH: Yes. Good morning, Commissioners.
- 9 MR. BLUESTEIN: Morning.
- 10 MR. LYNCH: For our voter registration report,
- 11 the unit has processed all affirmation and assistance
- 12 declarations from the November election. They have
- 13 processed 25,169 voter registration applications with
- 14 850 being paper.
- They are printing out close to 8,000 AVN letters
- 16 that they will be mailing out this week. They will
- 17 begin to print ID cards out after the New Year.
- 18 Excuse me. County Board will be preparing to mail out
- 19 certificates to the board workers winner -- the board
- 20 worker winners. They are hoping to have them mailed
- 21 out by early next week.
- The unit is also gearing up for community people
- 23 petitions for the May 19th primary. The election
- 24 board unit sent out 8,388 payroll checks to board
- 25 workers that worked in the November election.

This gives us the opportunity to reflect, make 9 10 practical improvements, and continue moving forward in a positive direction. 4	MS. DEELEY: Before we begin, I just want to go
5	over the rules before we proceed. The county board
6	will draw an order of board and division. If more
7	than one person is present to draw for the same race,
8	the candidate that was checked in first will draw
9	first, and so on.
10	The candidate that draws ball number one wins the
11	position of judge of election. To draw on behalf of a
12	candidate as a proxy, the proxy must have a letter
13	signed by the candidate authorizing them to do so.
14	The County Board of Elections employee will draw for
15	candidates not present.
16	For all races where no candidate or proxy is
17	present, we will use a random function in Excel to
18	decide the tiebreaker. The candidate that draws the
19	largest number in the random function will win the
20	tie.
21	Once a race has been drawn in person or in Excel,
22	we will not redo the tiebreaker draw for any reason.
23	All board worker position winners will be mailed a
24	certificate in the beginning of next week. Does
25	anybody have any questions before we proceed? Okay.
