

# 2025 INSTRUCTIONS FOR FILING AS A CANDIDATE OF A MINOR POLITICAL PARTY PHILADELPHIA COUNTY

(Not for use by Democratic or Republican Candidates)

In addition to political party nominations made at primaries, the Election Code permits political bodies to nominate candidates for public offices by filing political body Nomination Papers. Minor Political Parties recognized in Philadelphia are the **Libertarian Party, Green Party and the Working Families Party**.

The instructions detailed on this document only pertain to Nomination Papers for offices in the City of Philadelphia for recognized Minor Political Party candidates. Nomination papers for these municipal offices are now available online. It is the responsibility of the candidate(s) and their circulator to complete the paper(s) in the manner that is required by law.

# Instructions for Circulating Nomination Papers

Nomination Papers can be obtained by visiting the **"Candidates and Campaigns"** section of our website: vote.phila.gov. Papers must be printed on 8 ½" x 14" paper, 2-sided, **"Flip on Long Side"** (Head-to-Head). Candidates who do not have access to the internet may visit the County Board of Elections at City Hall, Room 142 to obtain Nomination Paper(s).

NOTICE: Duplicate Nomination Papers must be exact copies of the originals (8 ½" x 14" paper, 2-sided, "Flip on Long Side" (Head-to-Head).

# Prior to Circulation

Sections A and B on the top of Side A of each Nomination Paper page must be completed before signatures are obtained.

In the appropriate field on the online form, type the name of the candidate exactly as the candidate wants it to appear on the ballot. A nickname is allowed only if it is a derivative of the legal name, or it is how you are known in your community. If the candidate wishes to appear on the ballot with a nickname, a **Name Change Affidavit** should be completed and submitted with the Nomination Paper(s). The Name Change Affidavit is available in the **"Candidates and Campaigns"** section of our website at vote.phila.gov or in the County Board of Elections office at City Hall, Room 142.

- Instructions for completing preamble (Section A)
  Name of Minor Political Party All nomination papers must specify the name of the Minor Political Party which the candidate(s) represent.
- Instructions for completing candidate information (Section B) The name of each candidate, their occupation and place of residence must be listed. The correct title of the office which each such candidate is seeking must be indicated with the appropriate district number.

**NOTE:** More than one candidate may be nominated by one set of nomination papers, provided that all the signers are eligible to vote for all offices for which such nominations are made.

#### **Disaffiliation**

Any person who is a registered and enrolled member of a political party during any period of time beginning with thirty (30) days before the primary and extending through the General Election is **not eligible** to be the candidate of a minor political party in the General Election held in the same year. Similarly, anyone who has filed petitions to run in the Democratic or Republican Primaries is not eligible to be the candidate of a minor political party in the General Election held in the same year. Similarly, anyone who has filed petitions to run in the Democratic or Republican Primaries is not eligible to be the candidate of a minor political party in the General Election held in the same year, unless they voluntarily and timely withdraw their primary election nomination petitions with the county board of elections. Candidates that are removed by court order, including withdrawing their primary election nomination petitions due to stipulated defects, are not eligible to be the candidate of a minor political party in the General Election nomination petitions due to stipulated defects, are not eligible to be the candidate of a minor political party in the General Election held in the same year.

#### • <u>Circulation of nomination papers</u>

Signatures may be secured only between the tenth Wednesday before the Primary and August 1 of each year. For 2025, the circulation period begins on March 12<sup>th</sup> and ends on August 1<sup>st</sup>. Nomination Papers must be submitted <u>no</u> later than 5:00 PM on August 1, 2025.

#### **Statement of Circulator**

The Statement of Circulator on each Nomination Paper page must be signed after each Nomination Paper page is circulated. Due to recent law changes, the circulator's signature no longer needs to be notarized. The circulator <u>must</u> be a qualified and registered elector of Pennsylvania.

#### Signers

Signatures may not be obtained until March 12, 2025.

Signers must be a registered and enrolled elector (registered voter) in the City of Philadelphia and of the district referred to in the Nomination Paper (if applicable). Each signer must personally sign their name in the **"Signature of Elector"** column and print his or her name in the **"Printed Name"** column. Each signer must also insert their address (street and number) in the **"Place of Residence"** column exactly as it appears on their registration affidavit. The elector must also insert the date of signing in the **"Date of Signing"** column, which may be expressed in words or numbers (e.g., March 12, 2025, or 3/12/25).

# Number of Signatures Required:

The minimum number of signatures required is two percent of the largest entire vote cast for any officer (except a judge of a court of record) elected at the last preceding election held in the same electoral district, but it may not be less than the number required for nomination petitions for political party candidates for the same office. For the offices of City Controller and District Attorney, Minor Political Party candidates must submit 4,642 signatures.

\*If you live in any division listed below, the Inspector of Election signature requirement is as follows:

#### **Candidate's Affidavit**

The Candidate's Affidavit must either be signed and notarized or signed with the inclusion of a Candidate's Unsworn Statement.

If a candidate chooses the notarization option, the notarization must include the date of notarization, the notary public's signature, and the official rubber stamp seal. The candidate must be a U.S. citizen, meet the residency requirements for the office sought, and be a registered and enrolled elector (registered voter) of the Electoral District (i.e., Ward and Division) and of the party referred to in the Nomination Paper.

Alternatively, the PA Department of State has issued a "Candidate Declaration Unsworn Statement to be attached to Candidate's Affidavit where notarized statement is not available" (a.k.a Candidate's Unsworn Statement) form. Candidates now have the option of foregoing the notarization requirement only if they instead complete this Declaration. This form is included in this packet. The Declaration must be filed at the same time as the nomination paper(s) if used. <u>The blank fields within the body text of</u> <u>the Candidate's Affidavit must still be completed regardless of whether that candidate is</u> <u>foregoing the notarization requirement.</u>

Candidates only need to complete one Candidate's Affidavit or Unsworn Statement regardless of how many nomination paper(s) they submit.

# Filing Your Papers

Nomination Papers must be filed with the County Board of Elections, City Hall Room 142, <u>no later than 5:00 P.M. on August 1<sup>st</sup></u>. Papers will only be accepted by the County Board of Elections if the following criteria are met:

- 1. The Nomination Paper is printed on 8 ½" x 14" paper, 2-sided.
- 2. Candidate information is completed on the front of the Nomination paper.
- 3. Sections A and B are completed on the front of the Nomination Paper.
- 4. The Nomination Paper has at least the minimum number of signatures required for the office.
- 5. The Statement of Circulator is signed and dated.
- 6. A copy of Candidate's Statement of Financial Interest, required for candidates for City Controller and District Attorney, is included in the filing to the County Board of Elections. The original Candidate's Statement of Financial Interest Form must be submitted to the Department of Records at City Hall, Room 156 no later than 5:00 P.M. on August 1, 2025.
- 7. The Candidate's Affidavit is completed and signed.
- 8. The Candidate's Affidavit is notarized, or the Candidate Declaration Unsworn Statement is used in lieu of the notarization requirement (and the information in the affidavit is filled in completely).
- 9. Filing fee of \$100 paid by certified check or money order <u>ONLY</u> made out to the <u>City of Philadelphia</u> for <u>each candidate</u> for District Attorney and City Controller listed on the Nomination Paper.
- 10. The Nomination Paper is submitted no later than 5:00 P.M. on August 1, 2025.

All Nomination Paper pages must be bound together when filed. Please use binder clips. No staples.

Nomination Papers must include page numbers in consecutive order.

# Example:

Candidates who file two or more Nomination pages for themselves should number the pages as follows: Page 1 Side A, Page 1 Side B, Page 2 Side A, Page 2 Side B, Page 3 Side A, Page 3 Side B, Page 4 Side A, Page 4 Side B, etc.

Additional Nomination Papers filed to supplement or add to the original group of filed Nomination Papers must be numbered in consecutive order from where the first group left off.

# Notice of Withdrawal

Candidates who wish to withdraw their candidacy after filing Nomination Papers must submit a Notice of Candidate Withdrawal Form to the County Board of Elections, which will be available on our website or can be obtained from the County Board of Elections at City Hall, Room 142. The deadline for a candidate to withdraw from the ballot is August 8, 2025.

#### **Copies of Filed Nomination Papers**

Requests for copies of Nomination Papers may be made with the County Board of Elections, City Hall, Room 142. Copies will be available one business day after Nomination Papers are filed. Requestors can call (215) 686-VOTE or email phillyelection@phila.gov to request copies. Requests will be filled on a first-come, firstserved basis.

The fee for paper copies of Nomination Papers is \$0.25 per side (\$0.50 per Nomination Paper). Payment must be made by certified check or money order payable to the "City of Philadelphia." Cash or personal checks will not be accepted.

There is no fee for emailed digital copies or copies on USB drive.

#### Resign to Run

Please note Section 10-107(5) of the City Charter states, "No officer or employee of the City, except elected officers running for re-election, shall be a candidate for nomination or election to any public office unless the officer or employee shall have first resigned from [their] then office or employment."
