LOGIC & ACCURACY TESTING OBSERVATION: RULES & REGULATIONS¹

The purpose of these Rules and Regulations is to govern the conduct of observers permitted under the Election Code to observe the logic and accuracy testing for each election.

1. Each observer permitted under the Election Code may be present at the logic and accuracy testing.
2. Observers may not disrupt, engage with, or interfere with individuals performing the logic and accuracy testing, including by asking questions or making requests of Board of Elections staff while they are performing their duties.
3. Observers shall be positioned in an observation area designated by the Director of Election Operations or their designee. Observers shall not be physically positioned in any way that would interfere with the logic and accuracy testing.
4. Observers will be admitted into the observation area on a first-come, first-served basis. If the observation area reaches the maximum capacity allowed, observers may be refused entry to the observation area until a sufficient number of people leave the area.
5. Only small bags are allowed. Cell phones must be put away and may not be used at any time during observation. Audio and/or visual recording devices, and other visual aids, such as binocular or telescopes, are not permitted. Observers may bring a note pad and pen or pencil into the observation area. All bags may be subject to inspection.
6. The board will be available for the first hour of the first day of testing, to explain the process and respond to questions related to the testing. Periodic managerial check-ins will occur during the testing process. These are the only times for public comments or questions.
7. Photocopying of testing reports or other materials is prohibited.
8. Media is not permitted in areas where testing is actively occurring.
9. The failure of any observer to comply with these guidelines may result in removal of the observer.
